

ISOMORPHISMS OF LEXICOGRAPHIC POWERS OF THE REALS

SALMA KUHLMANN

ABSTRACT. Given a chain Γ , we consider the lexicographic order \mathbb{R}^Γ . If Δ is a chain such that $\mathbb{R}^\Gamma \simeq \mathbb{R}^\Delta$, we examine the question whether necessarily $\Gamma \simeq \Delta$. Under an additional hypothesis, we show that Γ and Δ will have the same order types of well ordered subsets. Among others, this yields an affirmative answer to the above question in the case where Γ and Δ are ordinals.

1. INTRODUCTION

Let Γ be a chain (that is, a totally ordered set), and let s be a mapping from Γ into the reals \mathbb{R} . Define *support* s to be the following subset of Γ :

$$\text{support } s = \{\gamma; s(\gamma) \neq 0\},$$

Consider now the set

$$\{s; s : \Gamma \rightarrow \mathbb{R}, \text{ support } \sim \text{ is well ordered}\},$$

and order it *lexicographically*:

$$s_1 < s_2 \text{ if and only if } s_1(\gamma) < s_2(\gamma), \\ \text{for the least } \gamma \in \Gamma \text{ such that } s_1(\gamma) \neq s_2(\gamma).$$

This is a well defined total ordering (cf. [FU]), and the totally ordered set thus obtained is called the *lexicographic product of the reals with exponent* Γ . We will denote it by \mathbb{R}^Γ . Recall that if X is a well ordered set, the *order type of* X (in notation $\text{o.t.}(X)$) is the unique ordinal isomorphic to X .

We examine the following problem: if Δ is any other chain and $\mathbb{R}^\Gamma \simeq \mathbb{R}^\Delta$ as chains, does it follow that $\Gamma \simeq \Delta$? Now given a totally

ordered Abelian group G , recall that the *archimedean equivalence relation* on G is given by

$$xEy \text{ iff } \exists n \in \mathbb{N} \text{ s.t. } \times|x| \geq |y| \text{ and } \times|y| \geq |x|.$$

Recall also that x is said to be *infinitely smaller than* y (in notation $x \ll y$) if and only if

$$\forall n \in \mathbb{N} : \times|x| < |y|.$$

Denote the equivalence class of $x \in G$ by $E(x)$. The set G/E of equivalence classes, ordered by

$$E(y) < E(x) \text{ iff } x \ll y$$

is a chain with last element $E(0)$; and the order type of the subchain $G/E \setminus \{E(0)\}$ is called the *rank* of G and denoted $\text{rank}(G)$. It is straightforward to see that the rank is an invariant for isomorphisms of ordered groups. Now if we endow \mathbb{R}^Γ with pointwise addition, it becomes a totally ordered Abelian group of rank precisely Γ (this group is called the *Hahn product of the reals with exponent* Γ). So the above stated problem is trivial if we assume $\mathbb{R}^\Gamma \simeq \mathbb{R}^\Delta$ as ordered groups. However, the rank is in general not an invariant for isomorphisms of chains (see the example, due to Charles Holland, at the end of section 2). In section 2, we show that if Δ is a chain in which \mathbb{R} does not embed, and if φ is an embedding of \mathbb{R}^Γ into \mathbb{R}^Δ , then for every ordinal α which is the order type of some well ordered subset of Γ , there is an element in Image φ with support of order type α as well. We deduce from this result that if α and β are ordinals such that $\mathbb{R}^\alpha \simeq \mathbb{R}^\beta$, then $\alpha = \beta$. Other corollaries, shedding light on the problem, are given at the end of section 2.

In what follows, unless otherwise stated, Γ will denote an arbitrary chain. Recall that a subset $I \subset \Gamma$ is an *initial segment* of Γ if and only if given $\gamma \in \Gamma$ and $i \in I$ such that $\gamma < i$, then $\gamma \in I$. Similarly, a subset $F \subset \Gamma$ is a *final segment* of Γ if and only if given $\gamma \in \Gamma$ and $f \in F$ such that $\gamma > f$, then $\gamma \in F$. In this article, given $a, b \in \{-\infty, \infty\} \cup \mathbb{R}$, $]a, b[$ will denote the open interval in \mathbb{R} with endpoints a and b . The closed interval will be denoted by $[a, b]$, for $a, b \in \mathbb{R}$, and so on for half closed intervals. If Z is a chain and X, Y are subchains of Z , $X \leq Y$ means: for all $x \in X$ and all $y \in Y$ we have $x \leq y$. Similarly for $X < Y$.

2. LEXICOGRAPHIC POWERS WITH ORDINAL EXPONENT

We need some definitions and lemmas:

Here, α, β, λ denote ordinal numbers, with $\beta \leq \alpha$. We write J (or J') to denote a chain in which the chain \mathbb{R} of the reals does NOT embed, and I (or I') for an initial segment of J .

Let us define

$$\mathbb{R}_\beta^\alpha = \{ \sim ; \sim \in \mathbb{R}^\alpha \text{ and support } \sim \subseteq \beta \} .$$

If $\beta < \alpha$ and $s \in \mathbb{R}_\beta^\alpha$ and $a \in \mathbb{R}$, define $s \hat{a} \in \mathbb{R}_{\beta+1}^\alpha$ as follows:

$$s \hat{a}(\lambda) = \begin{cases} s(\lambda) & \text{if } \lambda < \beta \\ a & \text{if } \lambda = \beta \\ 0 & \text{if } \beta + 1 \leq \lambda < \alpha . \end{cases}$$

Suppose now that we have an embedding of chains

$$\varphi : \mathbb{R}^\alpha \longrightarrow \mathbb{R}^J .$$

We say that $s \in \mathbb{R}^\alpha$ is β - I -determining if for all $s' \in \mathbb{R}^\alpha$, if $s' \upharpoonright \beta = s \upharpoonright \beta$, then $\varphi(s) \upharpoonright I = \varphi(s') \upharpoonright I$. Note that:

- 1) $\beta = \alpha \implies s$ is β - I -determining, for all $s \in \mathbb{R}^\alpha$, and
- 2) $\beta < \alpha \implies s$ is not β - J -determining, for all $s \in \mathbb{R}^\alpha$.

Lemma 2.1. *Suppose that $\beta < \alpha$, $s \in \mathbb{R}_\beta^\alpha$ is β - I -determining and*

$$\text{o.t. (support } \varphi(s) \cap I) = \beta .$$

Then there exist $A \subset \mathbb{R}$, $\text{card } A = 2^{\aleph_0}$, and $I' \supset I$ such that for all $a \in A$, $s \hat{a}$ is $(\beta + 1)$ - I' -determining and

$$\text{o.t. (support } \varphi(s \hat{a}) \cap I') = \beta + 1 .$$

Proof: Let $a \in \mathbb{R}$. Define

$$j_a = \min((\text{support } \varphi(s \hat{a})) \setminus I) .$$

Note that j_a is well defined for all $a \in \mathbb{R}$, except perhaps for only one b_0 : in fact, suppose $b_0 \in \mathbb{R}$ is such that $\text{support } \varphi(s \hat{b}_0) \subset I$; if $a \neq b_0$ then necessarily $\varphi(s \hat{a}) \neq \varphi(s \hat{b}_0)$ (since $s \hat{a} \neq s \hat{b}_0$). But since on the other hand $\varphi(s \hat{a}) \upharpoonright I = \varphi(s \hat{b}_0) \upharpoonright I$, then there exists $j \notin I$ such that $\varphi(s \hat{a})(j) \neq \varphi(s \hat{b}_0)(j) = 0$.

Note moreover that since φ preserves the order, we have for all $a \in \mathbb{R}$:

- if $\varphi(s \hat{a})(j_a) > 0$, then for all $a' > a$: $j_{a'} \leq j_a$ and $\varphi(s \hat{a}')(j_{a'}) > 0$, (1)
- if $\varphi(s \hat{a})(j_a) < 0$, then for all $a' < a$: $j_{a'} \leq j_a$ and $\varphi(s \hat{a}')(j_{a'}) < 0$. (2)

So let $a_0 \in \mathbb{R}$, and suppose without loss of generality that $\varphi(s \hat{a}_0)(j_{a_0}) > 0$ (the other case is treated by a symmetrical argument). Hence, for all $a \in [a_0, \infty[$ we have $\varphi(s \hat{a})(j_a) > 0$. So consider the decreasing map

from $]a_0, \infty[$ to J which to a associates j_a . If this map were injective, we would have an embedding of the chain \mathbb{R} in J . Hence there exist $a_1, a_2 \in]a_0, \infty[$ such that $a_1 < a_2$ but $j_{a_1} = j_{a_2}$. Set $j' = j_{a_1}$ and $I' = \{j \in J; j \leq j'\}$. Let $a', a'' \in]a_1, a_2[$. Then $j_{a'} = j' = j_{a''}$ (by (1)), moreover for $s' \in \mathbb{R}^\alpha$ we have:

$$\begin{cases} \text{if } s' \upharpoonright \beta + 1 = s \hat{\ } a' \upharpoonright \beta + 1 \\ \text{then } \varphi(s')(j) = \varphi(s \hat{\ } a')(j) = \varphi(s \hat{\ } a'')(j) \text{ for all } j < j'. \end{cases} \quad (3)$$

In fact, if $j \in I$, then it is immediate by hypothesis on s , and if $j \notin I$, then by definition of j' , $\varphi(s \hat{\ } a)(j) = 0$, for all $a \in [a_1, a_2]$. Let us show that then $\varphi(s')(j) = 0$. If not, let j be the least element such that $I < j < j'$ and $\varphi(s')(j) \neq 0$, and suppose first that $\varphi(s')(j) > 0$. But then $s \hat{\ } a_2 > s'$ whereas $\varphi(s \hat{\ } a_2) < \varphi(s')$, which is a contradiction. The case with $\varphi(s')(j) < 0$ is treated by a symmetrical argument, by considering $\varphi(s \hat{\ } a_1)$. So assertion (3) holds. Consider now the following subset of \mathbb{R} :

$$\pi_{a'} = \{\varphi(s')(j'); s' \in \mathbb{R}^\alpha \text{ and } \sim' \upharpoonright \beta + \aleph = \sim \hat{\ } \mathcal{D}' \upharpoonright \beta + \aleph\}.$$

Note that $s \hat{\ } a'$ is $(\beta + 1)$ - $(I' \setminus \{j'\})$ -determining (by (3)), and hence $s \hat{\ } a'$ is $(\beta + 1)$ - I' -determining if and only if $\pi_{a'}$ is a singleton. Moreover, $\pi_{a'}$ is bounded above in \mathbb{R} . To see this, it is enough to observe that if $a' < a''$ then $\pi_{a'} \leq \pi_{a''}$: Indeed, assume $s'' \in \mathbb{R}^\alpha$ such that $s'' \upharpoonright \beta + 1 = s \hat{\ } a'' \upharpoonright \beta + 1$. But then it is immediate by (3) that

$$\varphi(s')(j) = \varphi(s'')(j) \text{ for all } j < j'.$$

Since on the other hand $s \hat{\ } a' < s \hat{\ } a''$, we have $s' < s''$, so $\varphi(s') < \varphi(s'')$. It follows that $\varphi(s')(j') \leq \varphi(s'')(j')$ as required. Hence let

$$\begin{aligned} f :]a_1, a_2[&\longrightarrow \mathbb{R} \\ a &\mapsto \sup \pi_a. \end{aligned}$$

Then f is increasing. Since \mathbb{R} has the Countable Chain Condition, it follows that f has at most a countable number of discontinuities. Note that f is discontinuous at a point a if and only if π_a is not a singleton, hence set

$$A =]a_1, a_2[\setminus \{a; a \text{ is a point of discontinuity of } f\},$$

then $\text{card } A = 2^{\aleph_0}$, and we have the conclusions of the lemma. \square

Corollary 2.2. *There exists $s^\alpha \in \mathbb{R}^\alpha$ such that o.t. $(\text{support } \varphi(s^\alpha)) = \alpha$.*

Proof: By induction on $\beta \leq \alpha$, we construct $s^\beta \in \mathbb{R}_\beta^\alpha$, and I_β an initial segment of J such that

(i) $s^\lambda = s^\beta$ on λ , and $I_\lambda \subset I_\beta$ for all $\lambda < \beta \leq \alpha$

(ii) s^β is β - I_β -determining and o.t. ($\text{support } \varphi(s^\beta) \cap I_\beta = \beta$).

Set $s^0 = 0$ and $I_0 = \emptyset$. If β is successor, the construction is done using Lemma 2.1. If β is limit, set

$$s^\beta = \bigcup_{\lambda < \beta} s^\lambda \quad \text{and} \quad I_\beta = \bigcup_{\lambda < \beta} I_\lambda .$$

(i) is evident. For (ii), let $s' \upharpoonright \beta = s^\beta \upharpoonright \beta$ and $j \in I_\beta$, let us show that $\varphi(s')(j) = \varphi(s^\beta)(j)$. But $j \in I_\lambda$ for a $\lambda < \beta$, and $\varphi(s^\beta)(j) = \varphi(s^\lambda)(j) = \varphi(s')(j)$ (since s^λ is λ - I_λ -determining). For the second assertion of (ii), it is enough to observe that

$$\text{support } \varphi(s^\beta) \cap I_\beta = \bigcup_{\lambda < \beta} \text{support } \varphi(s^\lambda) \cap I_\lambda .$$

□

Now given any chain Γ , we associate to it the following set of ordinals:

$\text{WOT}(\Gamma) = \{\lambda; \text{there exists a well ordered subset of } \Gamma \text{ of order type } \lambda\}$.

Note that $\text{WOT}(\Gamma)$ is itself an ordinal, and $\text{WOT}(\lambda) = \lambda + 1$. Applying this last corollary we have shown :

Corollary 2.3. *Let Γ be any chain, and suppose that \mathbb{R}^Γ embeds in $\mathbb{R}^\mathbb{J}$. Then $\text{WOT}(\Gamma) \subset \text{WOT}(J)$.*

Proof: Let $\lambda \in \text{WOT}(\Gamma)$, then \mathbb{R}^λ embeds in \mathbb{R}^Γ . By hypothesis it follows that \mathbb{R}^λ embeds in $\mathbb{R}^\mathbb{J}$, so by Corollary 2.2, $\lambda \in \text{WOT}(J)$ as required. □

In particular, this shows that if J is the reverse of an ordinal, then so is Γ .

Another consequence of Corollary 2.2 (applied with $J = \lambda$) is

Corollary 2.4. *If $\varphi : \mathbb{R}^\alpha \rightarrow \mathbb{R}^\lambda$ is an embedding, then there exists an embedding of α in λ , that is $\alpha \leq \lambda$. If moreover φ is an isomorphism, then $\alpha = \lambda$.*

This last result can be restated as a theorem on ordered Abelian groups in the following way: Let G_i be an ordered Abelian group, for $i = 1, 2$. If $G_1 \subset G_2$, then there is a canonical embedding of $\text{rank}(G_1)$ into $\text{rank}(G_2)$. If this embedding is onto, we say that $G_1 \subset G_2$ is an *archimedean extension*. We say that G_1 is *archimedean-complete* if it admits no proper archimedean extension. Given any chain Γ , let $\mathbf{H}_{\gamma \in \Gamma} \mathbb{R}$ denote the Hahn product of the reals with exponent Γ . The following theorem is well known (cf. Fuchs [FU]):

Theorem 2.5. *An ordered Abelian group G of rank Γ is archimedean–complete if and only if $G \simeq \mathbf{H}_{\gamma \in \Gamma} \mathbb{R}$.*

We can now restate Corollary 2.4 as follows

Theorem 2.6. *Suppose that G_i is archimedean–complete and $\text{rank}(G_i)$ is an ordinal, for $i = 1, 2$. If $G_1 \simeq G_2$ as chains, then $G_1 \simeq G_2$ as ordered groups.*

In the next corollaries, which all follow from the proof of Corollary 2.2, $\coprod_J \mathbb{R}$ denotes the subchain of $\mathbb{R}^{\mathbb{J}}$ consisting of those sequences with finite support ($\coprod_J \mathbb{R}$ is called *the lexicographic sum*).

Corollary 2.7. *Let λ be an infinite ordinal. Then \mathbb{R}^λ does not embed in $\coprod_J \mathbb{R}$.*

Corollary 2.8. *Suppose that Γ is a chain possessing an infinite well ordered subset, then \mathbb{R}^Γ does not embed in $\coprod_J \mathbb{R}$.*

Corollary 2.9. *Suppose that Γ is a chain such that \mathbb{R}^Γ embeds in $\coprod_J \mathbb{R}$. Then Γ is the reverse of an ordinal.*

Corollary 2.10. *The chain $\mathbb{R}^{\mathbb{J}}$ embeds in $\coprod_J \mathbb{R}$ if and only if $\mathbb{R}^{\mathbb{J}} = \coprod_{\mathbb{J}} \mathbb{R}$, if and only if J is inversely well ordered.*

We close this section by giving the following example, due to Charles Holland, which shows that Theorem 2.6 is not true without the assumption on the ranks. We claim that $\mathbb{R}^{\mathbb{Z}}$ is isomorphic to $\mathbb{R}^{\mathbb{N}}$.

Proof: Let $K = \mathbb{R}^{\mathbb{N}}$. We partition K into a sequence $\{K_n\}$ of intervals, each isomorphic to K , and indexed by \mathbb{Z} as follows. Let

$$\begin{aligned} K_{2m} &= \{(m, x_2, x_3, \dots) \mid x_i \in \mathbb{R}\}, \\ K_{2m+1} &= \{(x_1, x_2, \dots) \mid x_i \in \mathbb{R} \text{ and } m < x_1 < m + 1\}. \end{aligned}$$

Now, we partition $\mathbb{R}^{\mathbb{Z}}$ into a sequence $\{J_n\}$ of intervals indexed by \mathbb{Z} and, again, each isomorphic to K . Let

$$\begin{aligned} J_0 &= \{(\dots, x_{-1}, x_0, x_1, \dots) \mid i < 0 \Rightarrow x_i = 0\}, \\ \text{for } n > 0, J_n &= \{(\dots, x_i, \dots) \mid i < -n \Rightarrow x_i = 0, \text{ and } 0 < x_{-n}\}, \\ \text{for } n < 0, J_n &= \{(\dots, x_i, \dots) \mid i < n \Rightarrow x_i = 0, \text{ and } x_n < 0\}. \end{aligned}$$

Since $m < n \Rightarrow K_m < K_n$ and $J_m < J_n$, and $K_n \simeq K \simeq J_n$, we obtain $\mathbb{R}^{\mathbb{N}} \simeq \mathbb{R}^{\mathbb{Z}}$.
